In the reference 4th read above, Sk. Asha, has filed O.A.No. 466 of 2018 in the Hon'ble Administrative Tribunal praying for to pass orders declaring the impugned selection notification of recruitment to the post of Degree Lecturer in Collegiate Education under Notification No. 26/2016 dated. 27.02.2018 issued by the 3rd respondent to the extent of English earmarked for B.C.(E) and P.H. (OH) category as arbitrary illegal, discriminatory and violative of Article 14,15,16,19 and 21 and policy under 39(a) of the Constitution of India and proviso to Rule 22(2) (a) R/W 22-A of the A.P. State and Subordinate Service Rules and consequently set aside the same and direct the respondents recast the selection list by placing the 1st ranker among B.C.(E) against G (General) roster point and consider applicant's candidature for appointment to the post of Degree Lecturer in English earmarked for Women category as per merit. The Hon'ble Tribunal has granted Interim orders dated.13.03.2018 in O.A.No.466 of 2018 as per the directions of the Hon'ble Tribunal posting orders were not issued to the candidates selected to the post of Lecturer in English under B.C.-E category.

In the reference 5th read above, the Hon'ble A.P. Administrative Tribunal in its orders dated, 25.06.2018 ordered as:

"... I am afraid, I cannot accept the said contention for the simple reason that the vacancy earmarked for B.C.-E (General) is at Roster Point No.44, whereas, the first Roster Point is at SI.No.19. Unless, the first roster point is filled up, that too in a carry forward vacancy, the respondents cannot go further down for the next vacancies under the same community, whether meant for Women or General. At any rate no candidate with lesser mark than the applicant was selected. Therefore, the applicant cannot have any grievance. Therefore, in my considered view the contention of the applicant is misconceived and untenable.

Point is answered accordingly in favour of the respondent/Service Commission.

Therefore, for all the above said reasons, the O.A. is devoid of merits and liable to be dismissed and is accordingly, dismissed. As a seguente dismissal of the O.A., the V.M.A. is allowed and the Interim Order dated, 13,03,2018 stands vacated."
