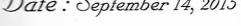

Curricular Aspects: College offers knowledge and skill based UG 2.1.1 Curricular Planning & Courses Curriculum is periodically revised by the Implementation: affillating University. Modifications suggested by the college through workshops. Skill training is provided to all students. 2.1.2 Academic Flexibility: College needs to introduce add-on courses. Limited vertical and lateral mobility exist. Being an affiliated college, it follows the 2.1.3 Curriculum Enrichment university syllabus. Activities involving examining the efficacy of the curriculum are not conducted, like organizing workshops, and feedback from the stakeholders. 2.1.4 Feedback System System of informal feedback from the students, alumni and parents exists. No visible effort for improving the system on the basis of feedback. 2.2 Teaching-Learning & Evaluation: 2.2.1 Student Enrollment and Profile: Most of the students are from economically and socially backward strata of the society. Good percentage of girl students' enrolment. College caters to the local need of education. 2.2.2 Catering to the Diverse Needs: Effective implementation uf` Knowledge Centre, meant for helping the backward classes. UGC sponsored programs like bridge course and remedial course are effectively implemented. 2.2.3 Teaching-Learning Process: Innovative teaching methods like smart class are used. Teaching plans and teaching diaries are

maintained.

2.2.6 Student Performance and Learnin Outcome:			
2.3Research, Consultancy & Extension	/		
2.3.1 Promotion of Research:	 Teachers are not sufficiently equipped in research. There is no visible effort to promote research culture among teachers. Only one minor research project has been carried out in the college. 		
2.3.2 Resource Mobilization for Research:	 No visible evidence for resource mobilization for research, except UGC. No efforts to create an interface with the industry. 		
2.3.3 Research Facility:	 No focus on providing research facilities in the college. Not many research journals are subscribed in the library. Inflibnet is available. 		
.3.4 Research Publications and Awards:	 There are few publications of the teachers. No evidence for publication in peer reviewed journals. 		
3.5 Consultancy:	No evidence of consultancy exists.		
3.6 Extension Activities and Institutional ocial Responsibility:	NSS unit is active. Regular extension activities like blood donation camps, visiting the old age home etc are being carried out. A village is adopted for extension activities.		
3.7 Collaboration:	 Evidence of collaboration with different agencies. Need to formalize the collaborative efforts. 		

2.4 Infrastructure and Learning Resources	NAAC for Quality and Excellence in Higher Education	
2.4.1 Physical Facilities:	 Adequate class room facilities and sports facilities are available. College lacks facility for expansion of academic programs. 	
2.4.2 Library as a Learning Resources:	 There is sufficient number of books and magazines available. Digital resources are available. Book bank scheme is in practice. Library automation is needed. 	
2.4.3 IT infrastructure	 Sufficient number of computers available. IT literacy is not high among teachers and students. IT is not used sufficiently. 	
2.4.4 Maintenance of Campus Facility:	 Stock register is up to date. Campus maintenance is good. 	
2.5 Student Support and Progression:		
2.5.1 Student Mentoring and Support	 Skill development is taken care of by Jawahar Knowledge Centre. Remedial classes are held. Visible efforts to collect endowment funds to support meritorious students. 	
2.5.2 Student Progression:	 Result of the college is comparably very good. Career counseling is active. 	
2.5.3 Student Participation and Activities:	 Regular participation of the students in various national cultural/sports events. One of the students received prize from the chief minister. Students are encouraged to participate in sports/cultural activities. 	



- 2.6 Governance and Leadership:
- 2.6.1 Institutional Vision and Leadership:
- provide good higher education to the surrounding backward area.
- Limited efforts are made by the college to fulfill it.
- Being a Government institution, it has limited flexibility in leadership.
- 2.6.2 Strategy Development and Deployment:
- There is no clear road map for development.
- Staff and students are involved in running the college.
- 2.6.3 Faculty Empowerment Strategy:
- Regular faculty members have undergone faculty development programs.
- No visible effort on the part of the college to empower teachers.
- 2.6.4 Financial Management and Resource Mobilization
- Financial records are well maintained and properly audited.
- Some efforts are made for resource mobilization, which need to be strengthened.
- 2.6.5 Internal Quality Assurance System
- No evidence for an effective functioning of IQAC.

- 2.7.1 Environment Consciousness:
- Solar energy is used.
- No visible effort to create environment consciousness among students.

There is no evidence of innovation at the college level.
